THE FOLLOWING TERMS AND CONDITIONS APPLY TO YOUR ACCESS AND THE USE OF THIS WEBSITE AND THE SERVICES PROVIDED HEREIN BY KMC. BY ACCESSING ANY PAGE OF THIS WEBSITE AND/OR USING THE SERVICES, YOU AGREE TO BE BOUND BY THESE TERMS AND CONDITIONS WITHOUT LIMITATION OR QUALIFICATION. IF YOU DO NOT ACCEPT THESE TERMS AND CONDITIONS, PLEASE IMMEDIATELY DISCONTINUE YOUR ACCESS TO THIS WEBSITE AND/OR USE OF THE SERVICES.

1. INTERPRETATION

“**Authorised User**” means an individual who is authorised by KMC to access the information services made available by KMC and who is (i) affiliated with KMC as a current student, library patron, staff, subscribers; or (ii) physically present on INCEIF and/or KMC premises (on-site visitor); and is synonymous with the term “Customers” or “INCEIF community” wherever used in other correspondence or documents.

“**Licensed Resource**” means online resource available under a licence from the publisher that permits certain uses and forbids others, as well as with usage restrictions imposed by providers.

“**Commercial Use**” means use for the purposes of monetary reward (whether by or for KMC, an Authorised User, or any other person or entity) by means of sale, resale, loan, transfer, hire, or other form of exploitation of the Licensed Resources.

2. USE OF ELECTRONIC RESOURCES

KMC portal is a gateway to physical and electronic scholarly information resources. The mission of the portal is to assist faculty, staff, students and INCEIF community to connect to the library resources and services they need for research, teaching and learning.

KMC subscribes to several electronic journals, books and other databases for use by Authorised Users. The terms and conditions for using these resources are set out in electronic resource license agreements with each publisher. It is the responsibility of individual users to ensure their use of electronic resources does not breach the terms and conditions specified in the license agreements. Licenses vary from publisher to publisher; however, the general principles are the same. KMC has negotiated license agreements for use of electronic resources, on behalf of its users, for purposes of research, teaching, learning, or other non-Commercial Use.

- These license agreements are formal contracts.
- Your access to a Licensed Resource can be blocked if inappropriate use is discovered.
- Inappropriate use can result in suspension of access for the entire institution.

Users are individually responsible for compliance with these terms.

2.1. Copyright Restrictions

All KMC users must respect the copyrights in works that are accessible through computers connected to INCEIF network. No copyrighted work may be copied, published, disseminated, displayed, performed or played without permission of the copyright holder except in accordance with fair use or licensed agreement. Commercial Use and systematic downloading, copying or distributing of information is expressly prohibited.

2.2. Licensing Restrictions

Licensed Resources are restricted to Authorised Users for purposes of research, teaching and learning. Under INCEIF's licenses for electronic resources, Authorised Users generally may not:

- permit anyone other than Authorised Users to use the licensed materials;
- modify or create a derivative work of the licensed materials without the permission of the licensor;
- remove, obscure or modify any copyright or other notices included in the licensed materials;
- use the licensed materials for commercial purposes, including but not limited to the sale of the licensed materials;
- reproduce or redistribute licensed materials in bulk or in a systematic way;
- post content or items from the licensed materials to social networking sites.

2.3. Third-party Terms and Conditions

Authorised User's rights and obligations relating to an external resource or website are governed by that service provider's terms and conditions, including any licence agreements.

KMC cannot accept any liability in connection with:

- The operation of any external resource or external supplier's website which Authorised User may access using Authorised User's user ID and password.
- The use by external service providers or suppliers of any personal information Authorised User pass to them.
- The operation of any software other than the software used (whether on its own or in conjunction with the software) to authorise access to an external resource or external supplier's website.

2.4. Responsibilities of the Authorised Users

The Authorised User hereby:

- undertakes to comply with all applicable laws (and shall not contravene any applicable law) of Malaysia relating to Services including without limitation the Copyright Act 1987 and any other related Acts.
- shall be responsible for the confidentiality of the user ID and password and not to transfer the user ID and password to any unauthorised persons and not reveal the same to any other person(s);
- is permitted to view, download, copy, print and save a copy of search results and/or individual article; unless otherwise stated.
- is permitted to use KMC resources for scholarly, educational or scientific research, teaching, and learning purposes.
- is permitted to send a copy of an article to another Authorised User. Transmitting, disseminating or otherwise making online content available to unauthorised users (i.e. sending to mailing lists or electronic bulletin boards) is not permitted.
- is permitted to post the URL to the publisher's version of the article on a class website (publisher links will allow only authorised users access). Posting the publisher's version or PDF of an article to an open website is not permitted.
- is not permitted to use of robots or intelligent agents to do systematic, bulk or automatic downloading.
- is not permitted to systematic downloading or printing of entire journal issues or volumes, or large portions of other e-resources.

3. USE OF KMC PHYSICAL LIBRARY

The following conditions do not cover every eventuality. Please follow any instructions received from KMC staff.

- Customers are required to display their staff card, student card or membership card throughout their stay in the KMC.
- Smoking, eating and drinking (except bottled water) is strictly prohibited inside KMC.
- Customers must conduct themselves properly and give cooperation in creating a conducive study and research environment.
- Silence is to be observed in KMC's serious reading area (Silent Zone). Discussion is allowed in the designated areas in a manner that does not cause discomfort to other users.
- Customers are required to switch their cell phones to silent mode and refrain from answering calls in KMC's serious reading area.
- Any mutilation or stealing of KMC materials/properties is liable to penalty or disciplinary action.
- Customers are not allowed to remove or change the placement of chairs, tables or any furniture in KMC. Reservation of seat is not permitted.
- Customers are allowed to bring in their personal belongings such as handbags, laptop or any electronic gadget. However, the KMC is not responsible for any lost or damaged personal items used in KMC.
- Customers are required to show all books and items they carry for inspection at the exit gate before leaving KMC should they trigger the alarm.
- Children below the age of 12 are not allowed to enter KMC.
